Entering freshmen must meet a weighted GPA of 2.5 or higher and at least 800 SAT (Critical Reading and Math only) or 17 ACT (Composite Score) Students who are recipients one year are eligible for consideration in any other year provided they continue to meet a cumulative GPA of 2.5, with award not to exceed four years. Preference should be given to need-based students who have declared a major. The value of this award shall not exceed the equivalent cost of that academic year's tuition and fees.
995673	Alvin E. Keels, Jr. Basketball Scholarship	The purpose of this scholarship is to recruit and retain highly qualified men's basketball players. Only students enrolled full time and meeting NCAA academic requirements are eligible for this scholarship.
995400	Agnes Whitfield Endowed Scholarship	This scholarship is available to student athletes majoring in Education.
995696	AKA Resource and Scholarship	The purpose of this scholarship is to reduce the disparities of black male matriculation on HBCU campuses. This scholarship is need based.
995777	AKA-HBCU Endowed Scholarship	This scholarship is available to students who meet the following criteria: Scholarship recipients must be in good academic standing with a GPA of 2.0 or greater; be full time; and, shall demonstrate financial need as determined by the ECSU Office of Student Financial Aid and Scholarships. Recipients are eligible for renewal consideration if the recipients continue to meet the scholarship criteria set forth and applies for renewal.
995524	Al Choudhury Memorial Scholarship	This scholarship shall provide a one-time scholarship of \$1,000 to one full-time undergraduate junior majoring in the Department of Mathematics and Computer Science or the Department of Natural Sciences majoring in Chemistry. Financial need and a GPA of at least 3.25 is required.
995409	Alexander O. Thweatt Endowed Scholarship	This scholarship is available based on the following criteria: Recipient must be a legal resident of North Carolina; maintain an overall GPA of 2.5 or better to continue eligibility; must show need; must major in Biology, Health Sciences or Business Management degree program and must provide the Office of Financial Aid and Scholarships a written acknowledgement to the donor prior to funds being released.
995551	Alpha Phi Alpha Endowed Award	This scholarship shall provide scholarships for undergraduate students at ECSU who demonstrate financial need and are in good academic standing by maintaining a GPA of 2.75 or better.
995401	Anne White Memorial Scholarship	This \$500 need-based scholarship is available to new freshman with a minimum 2.00 GPA.
995404	Athletic Director Scholarship	This fund shall provide scholarships to student athletes as set forth by ECSU Intercollegiate Athletics, CIAA and NCAA.

995742	Athletic General Scholarship	This scholarship is available to students who meet the following criteria: Student athletes receiving these funds must have a 2.5 GPA or better, maintain enrollment as a full-time student, entering freshmen must have a minimum SAT of 950; ACT equivalent, maintain an overall 3.0 GPA after the freshman year to continue eligibility, apply funds directly to tuition and fees only and be a legal resident of North Carolina.
995410	Belk Endowed Scholarship	This scholarship is available based on the following criteria: Recipient must be a legal resident of North Carolina; have a minimum SAT score of 900 for entering freshmen; have a high school GPA of 3.00 or higher; maintain enrollment as a full-time student with at least 15 hours each semester and maintain an overall average of 3.00 to
995685	Benard Peterson Scholarship	This scholarship is available to students who meet the following criteria: Current students enrolled at ECSU registered a minimum of 12 semester hours. 3.5 GPA minimum, theatre major classes, and be in good standing with ECSU
995540	Benjamin C. Saunders, Sr. and Aileen M. Saunders Scholarship of Excellence	This scholarship is available to students who meet the following criteria: Full-time, undergraduate, good academic standings with a minimum 3.0 cumulative GPA, need-based and successfully completed 30 credit hours.
995490	Bennie L. Williams Sr. Educational Scholarship	This scholarship is available to students who meet the following criteria: Full-time ECSU students majoring in Teacher Education. Student must have a 3.0 GPA or higher to continue eligibility. The scholarship is made available for incoming freshmen with a minimum entrance GPA of 2.8 and if they stay at the University for four consecutive years they must maintain a 3.0 or better GPA.
995714	Benny O. Hodges Endowed Scholarship	This scholarship is available for qualified student athletes at ECSU. Recipients shall demonstrate acceptable academic promise and shall have a record of good citizenship.
995536	Bishop KW Brown Scholarship Endowed Scholarship	This scholarship is available to students who meet the following criteria: Recipient shall be in good academic standing, maintain at least a 2.5 GPA and demonstrate financial need.
995412	Branch Banking and Trust (BBT) Endowed Scholarship	This scholarship is available based on the following criteria: Recipient must have a minimum SAT score of 800 and a grade point average of 3.0 or better.
995413	Carl M. and Mary Ann W. Franklin Scholarship	This scholarship is available based on the following criteria: the recipient must be a legal resident of North Carolina; have a high school GPA of 2.5 or higher, be full time, have a minimum SAT score of 900 and maintain an overall GPA of 3.00 to continue eligibility. This is a need-based scholarship.
995734	Carolyn Mitchell Cooper Ellis Endowed Scholarship	This scholarship is available to students who meet the following criteria: The student must possess a minimum grade point average of 2.0. There is no academic major restriction or residency requirement for awarding this scholarship.
995417	Centura Bank Endowed Scholarship	This scholarship is available based on the following criteria: The student must have completed the junior year; have a 3.0 cumulative GPA and 3.3 in major courses, have earned a minimum of 75 semester hours of which 30 are from ECSU and received a recommendation from the student's department head.

Student must be full time, have at least a 2.75 GA and be classified academically as a junior. The student must be admitted to the School of Education as an Education major.
995420	Charles Williams Association Memorial Endowed Scholarship	This scholarship is available based on the following criteria: Student must have graduated high school in a college preparatory program, have a 3.0 GPA or above, have a SAT score of 800 or above, be in the top 20% of graduating class and receive a recommendation from high school principal or guidance counselor and a community leader.
995474	Charlie H. and E. Louise Hughes Endowed Scholarship	This scholarship is available based on the following criteria: Only students enrolled at ECSU and carrying a semester course load of a minimum of 12 credit hours are eligible for this scholarship. The recipient(s) will be awarded the scholarship provided they major in Elementary Education, have a GPA of at least 3.0 (ECSU freshmen recipients must have a high school GPA of at least 3.0) and is a North Carolina native. Continued funding will depend upon the student (s) maintaining at least 3.0 GPA on 12 or more semester hours each semester. This scholarship is renewable.
995421	Choir Endowed Scholarship	This scholarship may be awarded to incoming freshmen and current students participating in the University Choir with a minimum of 12 credit hours per semester. Student must maintain 3.00 or higher GPA and display a work ethic conducive for leadership and excellence.
995530	Class of 1966 Academic Scholarship	This scholarship is available to students who meet the following criteria: recipient must be full-time; demonstrate good academic standing by maintaining a GPA of 2.5; and, first preference is for African American students as allowed by law. The award should not exceed the equivalent cost of the academic year's tuition and fees.
995503	Class of 1969 Scholarship	This scholarship is available to full-time ECSU students.
995681	Class of 1975 Scholarship	This scholarship is available to students who meet the following criteria: Current students enrolled at ECSU registered a minimum of 12 semester hours. 2.5 GPA minimum, maintain full time student status at ECSU. It is possible to retain scholarship (not to exceed 4 years) Funds maybe used to defray any costs associated with their educational program at ECSU. (e.g. tuition, books & other fees)
995500	Class of 1979 Scholarship	This scholarship is available to students who meet the following criteria: Full-time ECSU students with a high school GPA of 2.5 or higher. Student must maintain an overall average of 2.5 to continue eligibility.

995541	Cleveland A. Blount Jr Memorial Scholarship	This scholarship is an annual award that is selected by the Head Men's Basketball Coach. All students must meet the following criteria: Must have a 2.7 or higher GPA and be a member of the Men's Basketball Team.
995486	Darnell and Stephanie Johnson Endowed Scholarship	This scholarship is available based on the following: This is a scholarship of \$500 per student presented during the Honors Program each spring semester as follows: three students must be African American junior mathematics education majors with the three highest GPAs above 3.00 and three student must be African American junior elementary education majors with the highest GPAs above 3.00 in attendance at ECSU for three consecutive years. Additional dual scholarships may be awarded, if additional earned income is available.

The student must be in good academic standings with a 3.0 or above GPA, be academically classified as a junior (no seniors) and have documented leadership and community service.
995520	Desiree H. Kirby Trust Academic Scholarship and Talent Grant Endowed Scholarship	This scholarship shall provide four (4) scholarships in the amount of \$500 each. The first preference is that two awards are based on academic performance and two are for student athletes, student leaders or band or choir members. Additionally, students must: be full-time, undergraduate students, have a GPA of 2.5 or higher and demonstrate financial need.

995736	ECSU Wachovia Pharmacy Program Scholarship	This scholarship is available to students that meet the following criteria: Applicant must be incoming ECSU Freshmen interested in working towards admission into the UNC Chapel Hill/ECSU Doctor of Pharmacy Partnership Program. Any student academic deviation from the pre-pharmacy requirements could result in revocation of the scholarship award. Ideal applicant would have participated in the Wachovia Pharmacy Fellows Summer Program. Ideal applicant has completed 80 or more documented hours of pharmacy internship work under the direct supervision of a registered pharmacist. Scholarship applicants must have a cumulative high school or equivalent GPA of at least 3.0 or above. Undergraduate award recipient should maintain a cumulative GPA of at least 3.5, maintain the required relationship with their assigned pre-pharmacy academic advisor, and avoid academic deviation from the pre-pharmacy requirements to maintain their award each semester. When applicable, PharmD students must maintain an overall GPA of at least 3.0. Preference will be given to students from the 21-County ECSU service area. All applicants must apply, be admitted, or enrolled full-time at ECSU to be eligible. The post graduate service award requires that applicants be prior scholarship recipients, registered pharmacists in NC and provide a signed letter from a pharmacist employer in the 21 - county area.
